## **PLAN OF THE LAWYER REFERRAL SERVICE**

The Rockland County Bar Association under the guidance of the American Bar Association, has established a Lawyer Referral Service (“The Referral Service”) on a County-wide basis. The office is located at the Rockland County Bar Association, 337 North Main Street, Suite 1, New City, New York 10956.

The willing participation and continued support of lawyers practicing in Rockland County is crucial to the smooth operation of the Referral Service.

### **The purposes of the Referral Service are:**

- To be a public service, available to assist the general public by providing an alternative source for any person who can afford to pay a reasonable fee for legal services and who does not have a lawyer by providing a referral to a lawyer who practices in Rockland County.
- To provide a vehicle for persons who need a legal representative but whose earnings or assets are too high for the standards set by Rockland County Legal Aid Society or Pro Bono New York; and
- To establish a better rapport between the public and the legal profession.

The Referral Service Plan is not designed to take clients away from attorneys. In fact, a cardinal principle will be to establish whether a prospective client has a present attorney. The Referral Service will not refer the client to a panel attorney of the Referral Service if we learn that a prospective client has seen other attorneys in an effort to bargain on fees. Additionally, a prospective client shall not be referred to a panel attorney if the prospective client has previously engaged the services of a lawyer on the same matter unless the original-lawyer-client relationship has been properly terminated in writing.

1. Membership on the Referral Service Panel is by individual attorney and not by law firm.
2. A panel attorney must abide by all of the rules of the Referral Service and will in no way hold, or claim to hold, the Rockland County Bar Association, the Referral Service or any of the members, officers or employees liable in connection with any referral made.

## OBTAINING OUT-OF-STATE WITNESSES AND DOCUMENTS

Subpoenas duces tecum and ad testificandum cannot be served upon non-parties who are out of state (Judiciary Law 2-b[1]). Doing so, where there is no jurisdictional predicate over the non-parties, renders such subpoenas void and unenforceable (Peterson v Spartan Industries, Inc., 40 AD2d 807, aff'd., 33 NY2d 463). There are cases, conceivably, where out-of-state documents or witnesses are crucial to a party's claim or defense. What is an attorney to do if non-party materials or witnesses, which are out of reach under the normal subpoena processes, are needed to by a party to establish claims or defenses via summary judgment or at trial? The answer lies in either CPLR 3108 or the Uniform Interstate Deposition and Discovery Act ("UIDDA"), depending on the state where the non-party documents or witnesses are located.

CPLR 3108, which has been on the books since 1962, permits a New York court to execute a "commission" reflecting an official seal, requesting that it be honored by an out-of-state court. The commission, when presented to the out-of-state court, should result, as a matter of comity, in the execution by the foreign court of a subpoena that would be served and enforceable in the foreign state. If the subpoena seeks non-party documents, the responsive records may be transmitted directly to counsel in the normal course. If the subpoena is for either pre-trial deposition or trial testimony of a non-party witness, the testimony is to be taken within the foreign state. While CPLR 3117(a)(3)(ii) permits the reading the transcript at trial, Uniform Rule 202.15 and CPLR 3113(b) also permit its videotaping for use in accordance with that statute.

New York courts will not issue commissions under CPLR 3108 merely upon request. The party seeking the commission must meet a two-part test. First, the party must show that the foreign state witness or document custodian will not cooperate with a discovery notice and will not otherwise voluntarily come to New York to participate in the pre-trial discovery or trial (Susan A. v Steven J.A., 141 AD2d 790, 791). The second test is to show that the non-party document or testimony is material or necessary to the party's claim or defense (Misfud v City of New York, 208 AD2d 701, 702).

The commission procedure of CPLR 3108 can sometimes be too time-consuming, particularly when there is a fast-approaching trial date, as it is layered with two different courts, a process server, and a non-party responder. New York adopted the streamlined procedures of the UIDDA in 2011, as embodied in CPLR 3119. Under the UIDDA, the party seeking out-of-state documents or deposition testimony may present a validly-executed New York subpoena to the clerk of the county in the foreign state where the discovery or testimony is sought. The clerk is to ministerially and promptly issue a parallel foreign state subpoena for service upon the person to whom it is directed. The language of the UIDDA does not speak to trial testimony, but only discovery. The subpoena is to be served, and any discovery issues resolved, under the laws of the foreign state (UIDDA secs. 4, 5, and 6). While attorneys in out-of-state actions may utilize CPLR 3119 to obtain records or deposition testimony from non-party New Yorkers, New York attorneys may only use the UIDDA in the 38 other states that have adopted it so far (Uniform Law Commission, available at [www.uniformlaws.org/Act.aspx?title=Interstate%20Depositions%20and%20Discovery%20Act](http://www.uniformlaws.org/Act.aspx?title=Interstate%20Depositions%20and%20Discovery%20Act)). Attorneys who wish to use the UIDDA must first determine that the foreign state has adopted it, and if so, carefully follow the language of the version adopted by that foreign state. Otherwise, attorneys must use the more cumbersome commission procedure of CPLR 3108.

CPLR 3108 and the UIDDA are not needed if out-of-state document custodians or witnesses are cooperative. But since the acquisition of documents or testimony is sometimes crucial from uncooperative sources, and the time elements of CPLR 3108 or the UIDDA are controlled by others, attorneys should utilize the available procedures as soon as practically possible in litigations.

**COMMERCIAL LITIGATION ISSUES OF INTEREST**

January 2019

Your client, a foreign corporation with its principal U.S. office in New York, contracted to provide consulting services over a three-month period to a Delaware corporation located solely in Seattle. Your client did not receive all of the payments due for its services. You commenced an action for breach of contract in the Southern District of New York, claiming long-arm jurisdiction. You allege that the agreement contains a New York choice-of-law provision, that notices were to be sent to your client in New York, that the defendant communicated by email and telephone to your client in New York, that your client performed the services in New York, and that the defendant maintains an interactive website to communicate with users in all states. The defendant has moved to dismiss for lack of personal jurisdiction.

Will you defeat the motion?

The answer is no.

In *ICO Servs. Ltd. v. Coinme Inc.*, NYLJ 1545233235NY18Civ42, 18 Civ. 4276 (S.D.N.Y. December 17, 2018), ICO, a New York-based Hong Kong firm, contracted to provide consulting services for Coinme, a Delaware corporation offering cryptocurrency from its sole office in Seattle, Washington. The agreement was negotiated by Coinme from Seattle and signed by ICO in Hong Kong. The agreement contains a New York choice-of-law provision, and provides for notices to be given to ICO in New York, with no provision for where payments were to be made. The plaintiff performed the consulting services under the agreement primarily in New York from November 2017 to February 2018, during which time the parties exchanged emails and spoke by telephone.

ICO sued Coinme in New York for failing to pay half of what was owed under the agreement, claiming long-arm jurisdiction under CPLR § 302(a)(1), which provides for personal jurisdiction over a non-domiciliary who “transacts any business within the state or contracts anywhere to supply goods or services in the state.” Coinme moved to dismiss for lack of personal jurisdiction.

The Court weighed the four factors provided in *Sunward Elecs., Inc. v. McDonald*, 362 F.3d 17, 22 (2d Cir. 2004), for determining whether there is personal jurisdiction under New York’s long arm statute, noting that no one factor is dispositive, and the ultimate determination must be made based on the totality of the circumstances.

The first factor – an “on-going contractual relationship with a New York corporation” – weighed against personal jurisdiction. The Court determined that the three-month contract was a “single short-term contract” insufficient to constitute an “ongoing contractual relationship” with ICO, citing *Schentag v. Nebgen*, No. 17 Civ. 8734, 2018 WL 3104092, at \*19 (S.D.N.Y., June 21, 2018).

The second factor – negotiation or execution of the contract in New York and defendant’s visit to New York after execution of the contract – also weighed against personal jurisdiction. Coinme negotiated and executed the contract outside of New York, and ICO did not state where it negotiated and executed the contract. Coinme did not come to New York.

The third factor – the choice-of-law clause – weighed in favor of ICO. Although this factor was significant, it was ruled insufficient standing alone, citing *CutCo Industries, Inc. v. Naughton*, 806 F.2d 361, 367 (2d Cir. 1986).

The fourth factor – a provision for notices and payments into the forum state, or supervision of the parties by the New York corporation – weighed neither for or against New York as a forum. The contract called for notices to be sent to New York, but did not provide for payments in New York, nor subject either party to supervision here.

As to Coinme’s communication with ICO in New York by email and telephone, the Court ruled that such activity was not engaged in by Coinme in New York, and was insufficient to constitute the transaction of business in New York, citing *Kennedy v. Yousaf*, 127 A.D.3d 519, 520 (1st Dep’t 2015).

Finally, Coinme’s interactive website was ruled insufficient to confer jurisdiction, because there was no nexus between the website and ICO’s claims. There must be an “articulable nexus” and “substantial relationship” between the transaction and the claim.

The lesson? A short-term contract with an out-of-state party will not, even with a New York choice-of-law provision, constitute an ongoing contractual relationship sufficient to obtain personal jurisdiction in New York courts over disputes arising from the contract. Consider a provision for jurisdiction of disputes in New York courts, a provision for notices and payments to be sent to New York, and execution of the contract in New York.

## **NEW CLE REQUIREMENT**

**In addition to ethics and professionalism, skills, law practice management, and areas of professional practice, a new category was added for diversity, inclusion and elimination of bias courses. This category of credit is effective January 1, 2018.**

**Experienced attorneys due to re-register on or after July 1, 2018 must complete at least one credit hour in the Diversity, Inclusion and Elimination of Bias CLE category of credit as part of their biennial CLE requirement. The transitional CLE requirement for newly admitted attorneys remains unchanged. For more information about the CLE Rules, visit [nycourts.gov/Attorneys/CLE](http://nycourts.gov/Attorneys/CLE).**

## **CLE REQUIREMENTS**

**Newly admitted attorneys must complete 32 credit hours of accredited “transitional” education within the first two years of admission to the Bar. Sixteen (16) credit hours must be completed in each of the first two years of admission to the Bar as follows: 3 hours of Ethics and Professionalism; 6 hours of Skills; 7 hours of Practice Management and/or areas of Professional Practice. Experienced Attorneys must complete 24 credit hours of CLE during each biennial reporting cycle: 4 credit hours must be in Ethics and Professionalism. The other credit hours may be a combination of the following categories: Ethics and Professionalism, Skills, Practice Management or Professional Practice.**
